European elections - June 9th, 2024

The European elections will be held on June 9th, 2024. These elections are open to all Luxembourg nationals, who are automatically registered on the electoral roll as soon as they meet the conditions required by law, as well as to any other European Union nationals who live in Luxembourg and are registered on the electoral roll for the European elections. Each voter voting in Luxembourg is entitled to 6 votes.

The deadline for registration on the electoral roll is April 15th, 2024 at 5 p.m.

There are two possible options to register:

- apply electronically via MyGuichet.lu
- go to your municipal administration of residence.

Once voters are registered, they are automatically registered again for the next European elections and are therefore required to vote. If you move to another municipality in Luxembourg, you are automatically transferred to the electoral roll of your new municipality of residence.

To vote in Luxembourg individuals need to

- Be Luxembourgish or EU citizen;
- Be 18 years of age on election day (June 9th, 2024);
- Be a resident in Luxembourg when you register to vote and on the day of the election;
- Register on the electoral roll until 5 p.m. on April 15th, 2024.

Voting rights for all EU citizens

European Union nationals residing in the Grand Duchy have the right to vote. They can choose between two methods of voting for the European Parliament.

1) They may take part in the election of Luxembourg's Deputies to the European Parliament.

If they opt for this method, they must register on the electoral roll of their municipality of residence, under the condition that they are at least 18 years old on the day of the elections. EU nationals who are already on the electoral roll for the European elections no longer need to register. Once registered, voting is compulsory for subsequent elections. Please note that registering to vote in municipal elections does not replace registering to vote in European elections. It is also possible to deregister at any time.

2) They may also vote for representatives from their home country. In this case, they must contact the relevant authorities in their country of origin, in particular their embassy or consulate.

Postal voting

Any registered voter on the European electoral roll in Luxembourg may request a postal vote in the European elections from the municipality in which he or she is registered. No justification is required for requesting a postal vote.

From March 17th 2024, the request can be made either:

- by post in writting or on a pre-printed form;
- by electronic submission via myguichet.lu.

The application must indicate:

- surname, first name and place of residence;
- date and place of birth;
- the address to which the poll card should be sent.

The request must be submitted to the College of Aldermen before:

- Tuesday, April 30th, 2024 for ballot papers sent to an address abroad;
- Wednesday, May 15th, 2024 for ballot papers sent to a national address.

Any request for a postal vote submitted to the municipality after the respective deadlines, which are April 30th, 2024, or May 15th, 2024, cannot be considered.

A voter who has requested a postal vote and whose request has not been refused is no longer entitled to vote in person at a polling station on the day of election.

Voting

Voters are admitted to the polling station on election day from 8 a.m. to 2 p.m. On election day, voters are required to bring a valid identity card, passport, residence permit, or residence card. Presentation of the invitation letter is not required.
