



Excursion to the European Parliament in Brussel on July, 14th 2026

The Leisure Committee, in cooperation with the College of Aldermen, is organizing an excursion to the European Parliament in Brussels. Registration for participation in this excursion is open to everyone aged 12 and older. The number of participants is limited to 40 people. Students will be given priority.

You can register until the June, 25th 2026. Please fill out the form and submit it to the municipal administration office. For underage participants, the Signature of a parent on the form is required.

On the day of the trip, any minor must either be accompanied by a parent or legal guardian, or present a parental authorization allowing participants under the age of 18 them to be accompanied by another adult.

The European Union (EU) is a union of European states that work together to maintain peace and prosperity in Europe. For this purpose, common rules are established within the EU. The European Union currently has 27 member states, including Luxembourg.

Just like a country, the EU also has a kind of government: the European Parliament, the European Commission, and the European Council. The European Parliament, comparable to our "Chamber of Deputies," has its seat in Brussels and Strasbourg.

With our guide, the Luxembourg Member of the European Parliament Charles Goerens, we will visit the largest transnational parliament in the world and discover how and where the rules for Europe are drafted, debated, and decided. The visit will give you an insight into the role of the European Parliament and the work of its members.

Programm:

- 07:00 a.m.: Departure by bus from Flaxweiler (The bus will first travel through the villages to pick up participants. The exact timetable will be communicated soon.)
- 10:00 a.m.: Arrival in Brussels and visit of the European Parliament
- 11:00 a.m.: Meeting with Mr Charles Goerens
- 12:00 p.m.: Visit of the Parliament's gallery
- 12:30 p.m.: Group lunch
- 14:00 p.m.: Afternoon at Leisure
- 17:00 p.m.: Return by bus to Flaxweiler (The bus will then bring participants back to their respective Villages.)

The municipality covers the transportation costs.

Attention: Each participant must be in possession a valid identity card during the excursion. Minor students must also present a parental authorization.

To request an authorization, a parent must appear in person at the municipal administration office.
